

## **STANDS4ME Service Conditions**

This document defines the conditions under which you can use the STANDS4ME platform and the services provided by D-Side SA.

PLEASE READ THESE TERMS OF SERVICE CAREFULLY BEFORE USING OUR SERVICES, AS YOU ARE ENTERING INTO A BINDING AGREEMENT WITH D-SIDE SA, AVENUE L. MOMMAERTS 24, 1140 BRUSSELS, BELGIUM. IF YOU DO NOT ACCEPT (OR DO NOT COMPLY WITH) THE TERMS OF SERVICE, DO NOT USE OR ACCESS OUR SERVICES.

These terms do not interfere with any obligation or authorization provided for in any other agreement between you and D-Side SA.

### **Eligibility**

By registering to use the services, you confirm that you are at least 18 years old. By using our services, you confirm that you have full legal capacity to enter into a binding agreement, that you provide true, accurate, existing and complete information when requested, and information that is also consistent with these terms, that you will not use the services in violation of these terms or applicable laws. ### **Registration**

During the registration process, you will be asked to provide certain personal information, the collection, use and storage of which is governed by our privacy policy and applicable laws. Users are invited to provide true, accurate and complete information about themselves, as indicated in the forms provided for this purpose. If you provide information that is contrary to the aforementioned conditions, we may refuse or withdraw your access to part of our services. We are not responsible for any failure to provide the services that may be caused by information that is not true, accurate, existing or complete.

You understand that it is your responsibility to protect the confidentiality of your access information. You are responsible for any activity that occurs under your account. If you discover or suspect that someone has accessed your account without authorization, we recommend that you contact us immediately.

### **Personal Data**

In the framework of the STANDS4ME platform, D-side SA, as data controller, processes users' personal data in accordance with the applicable legislation on privacy with regard to the processing of personal data.

Users are informed that their personal data is processed exclusively for the purpose of managing the STANDS4ME platform and ensuring the proper execution of the commercial relationship, processing requests and orders, for the promotion and prospecting of STANDS4ME and for internal statistics of performance evaluation.

The personal data processed are as follows: surname and first name, email address, mobile phone number, job title.

D-side SA will not transmit users' personal data to third parties, except within the strict framework of the proper execution of the order. The third party is committed to D-side SA to respect a confidentiality agreement on the data shared.

The collected data will be stored by D-side SA for a period of 5 years.
